### **GDPR**

As a society we are here to help you as members to promote your Salers animals and the breed as a whole. In order to achieve this when you signed up for membership you will have signed to say you agree for your information to be published, which acts as a directory of breeders both online and in the form of the society database.

On the 25 May 2018 the UK adopted the new EU General Data Protection Regulations (GDPR). GDPR brings in new regulations as to how personal data can be collected, stored and processed. The Society is therefore in the process of reviewing its policies and procedures, and as part of the review we need you to give us your express permission to continue to publish your personal information and for it to be shared freely with those requesting contact details over the phone.
